The purpose of this call is to enable the Commission to draw from a list of potential contractors who could be entrusted with contracts in connection with activities of the Directorate.

Persons who are interested in having their name entered on a list of candidates are invited to submit an application in accordance with the rules set out below.

The list drawn up following this notice will be used solely for contracts whose estimated value is below the thresholds laid down in the relevant public procurement Directives (currently the threshold is EUR 133 000) or for service contracts.

The authorising department will draw up a list of candidates who meet the criteria. For each specific contract relating to the field described at point 3(a), the authorising department will send the specifications to all the candidates on the list or to some of them, selected on the basis of special pre-selection criteria for the contract concerned.

The applicants that are part of the (2006–2009) list will not automatically be included in the new list 2009–2012. They have to reapply in order to be on the new list.

In the European Union, almost 100 million citizens of all ages invest their time, talents and money to make a positive contribution to their community by volunteering in civil society organisations, youth clubs, hospitals, schools, in sport clubs, etc.

For the Commission, volunteering is an active expression of civic participation which strengthens common European values such as solidarity and social cohesion. Volunteering also provides important learning opportunities, because involvement in voluntary activities can provide people with new skills and competences that can even improve their employability. This is especially important at this time of economic crisis.



Volunteering plays an important role in sectors as varied and diverse as education, youth, culture, sport, environment, health, social care, consumer protection, humanitarian aid, development policy, research, equal opportunities and external relations.

#### Objectives of the Year:

- 1. To create an enabling and facilitating environment for volunteering in the EU;
- 2. To empower volunteer organisations and improve the quality of volunteering;
- 3. To reward and recognise volunteering activities; and
- 4. To raise awareness of the value and importance of volunteering.

European Parliament and Council of the EU granted a dedicated budget for the European Year of Volunteering, as follows: European Year of Volunteering 2011: **EUR 8 million**. Preparatory actions 2010: **EUR 3 million**

#### Health 2020 - New WHO Initiative

The WHO Regional Office for Europe's annual Regional Committee meeting agreed on the development of a new European health policy to accelerate progress towards achieving the European Region's health potential by 2020 by addressing key public health and health policy challenges.

A new study on health inequalities in Europe will provide a basis for this health policy. This study will analyze the social determinants of health, in particular as they affect the health divide in Europe, as well as the social gradient in societies, vulnerable population groups, gender and the impact of all these aspects on health policies and actions by governments. It will also address all the other determinants of health, such as lifestyles, the environment and climate change, and food safety.



Health 2020 will also focus on new challenges such as, non communicable diseases (such as cardiovascular diseases, cancer, diabetes and mental disorders), along with the diseases of ageing and disability.

## EU publication "Investing in well-being at work Addressing psychosocial risks in times of change"

The EU publication "Investing in well-being at work Addressing psychosocial risks in times of change (09/11/2010)" looks at the psychosocial risks in time of change.

There is a growing body of evidence of the potential negative effects that restructuring has on the health of workers and their families. Uncertainty and job insecurity also represent an important link between restructuring programmes and effects on employees' health (depression, absenteeism, difficulty sleeping ...).

This leaflet highlights some of the central issues associated with organizational change, restructuring, health and well-being, and explains what can be done to prepare organizations and people more effectively for major changes. # The EC launched a public consultation on the professional qualification Directive 2005/36/EC during 07/01/2011 to 15/03/2011.

This Directive, adopted in 2005, sets the rules for mutual recognition of professional qualifications between Member States. The reform of the system of recognition of professional qualifications as a means to facilitate mobility is one of the priority actions proposed by the Commission in the Single Market Act. With the view to preparing this reform, the Commission launched in March 2010 a major evaluation of the Professional Qualifications Directive.

As a first step in the evaluation process, the Commission reached out to competent authorities and national coordinators, who draw "experience reports" giving valuable information on how the rules work in practice. The consultation constitutes the second step of the evaluation process. The main objective is to consult stakeholders on three major challenges for the reform of the system of recognition of professional qualifications:

- simplifying the existing rules to the benefit of individual citizens;
- integrating professions into the Single Market;
- injecting more confidence into the system.

The recently finished ProMenPol Project had developed one of the most visited mental health promotion websites in Europe with its functionality of tools and methods for mental health promotion across the lifecycle.

It is to be maintained and augmented with the mental health promotion portal. This Portal extends the range of information to include a site dedicated to e-learning in relation to mental health promotion and a site dedicated to supporting the implementation of mental health promotion in different settings, including workplace.

The structure of the new portal is:

- ENMHP: European Network for Mental Health Promotion (ENMHP). This site will act as an umbrella for mental health promotion websites. It will also build on the network of mental health promotion professionals

- ProMenPol: This site will contain all of the material and tools developed within the lifetime of the ProMenPol Project and beyond. It will continue to be updated for the next three years.
- Mind-Health: This site is dedicated to providing training in mental health promotion via an e-learning package that is under development.
- MHP-Hands: This site is dedicated to the development and testing of a set of implementation manuals for mental health promotion. Its aim is to support the practice of mental health promotion in the field.
